The annualized current yield and effective yield for the Canada Life No-Load Money Market (Portico) Fund for a seven day period ending December 31, 2020 are 0.039 per cent and 0.039 per cent respectively. This is an annualized historical yield based on the seven day period ending on December 31, 2020 and does not represent an actual one year return.
