The last paragraph of the Investment managers section is hereby deleted and replaced with this updated paragraph:

GWL Realty Advisors Inc., Setanta Asset Management Ltd., Canada Life Asset Management, Irish Life Investment Managers Limited and Canada Life Investment Management Ltd. are wholly owned subsidiaries of The Canada Life Assurance Company. Putnam Investments Canada ULC is a wholly owned subsidiary of Great-West Lifeco Inc. The Canada Life Assurance Company and Mackenzie Investments are members of the Power Corporation group of companies. Policies are in place to avoid any potential conflicts of interest.

The Fund Facts, forming part of the Canada Life segregated fund policies information folder originally with London Life, are amended to reflect where a segregated fund is currently managed by:

- GLC Asset Management Group Ltd. it will now be managed by Mackenzie Investments except where PSG appears in the segregated fund name.
- GLC Asset Management Group Ltd. but includes PSG in the name of the segregated fund, it will be managed by Canada Life Investment Management Ltd.

No other changes were made to either the information folder or Fund Facts.

This addendum forms part of your information folder containing important provisions that you should read prior to investing. The information folder contains general information about your policy and includes a summary of the various types of risks that may apply when you invest in a segregated fund. This addendum is not an insurance contract.
