Management Discussion of Fund Performance

June 3, 2021

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the period ended March 31, 2021 (the "period"), that have affected the Fund's performance and outlook. If the Fund was established during the period, "period" represents the period from inception to the end of the fiscal period. For information on the Fund's longer-term performance, as applicable, please refer to the *Past Performance* section of the report. In this report, "CLIML" refers to Canada Life Investment Management Ltd., the manager of the Fund. CLIML is wholly owned by The Canada Life Assurance Company ("Canada Life"). CLIML has entered into a fund administration agreement with Mackenzie Financial Corporation ("Mackenzie"), an affiliate of CLIML and Canada Life, for administrative services (see *Recent Developments*). In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

The Fund seeks long-term capital growth and dividend income by investing primarily in equities of companies located anywhere in the world.

Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for medium- to long-term investors looking for a global income-oriented equity fund to hold as part of their portfolio, who can handle the volatility of stock markets and who have a low to medium tolerance for risk.

Results of Operations

Investment Performance

The performance of the Fund's Q Series (formerly Quadrus Series) securities is discussed below. The performance of all series is shown in the *Past Performance* section of the report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series.

During the period, the Fund's Q Series securities returned 20.6% (after deducting fees and expenses paid by the series). This compares with a return of 37.3% for the Fund's broad-based index, the MSCI World (Net) Index, and a return of 20.9% for the Fund's narrow index, the MSCI World High Dividend Yield (Net) Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Most global equity markets rebounded to all-time highs following the pandemic-driven collapse in March 2020. News of successful vaccine development helped lift stocks expected to benefit from the easing of lockdown restrictions. However, waves of COVID-19 infections and hospitalizations in the second half of the period slowed reopening in many regions. In response, governments continued to provide significant stimulus to boost struggling economies. Currency movements reduced returns in Canadian dollar terms.

Within the MSCI World High Dividend Yield (Net) Index, Denmark, Ireland and Sweden were the strongest-performing countries in Canadian dollar terms, while Switzerland, Austria and Israel were the weakest. The materials, consumer discretionary and industrials sectors were the strongest performers, while communication services, health care and utilities were the weakest.

The Fund underperformed both the broad-based index and the narrow index, with stock selection in the industrials and financials sectors detracting from performance. Contributors to performance relative to both the broad-based index and the narrow index included stock selection in the consumer staples sector and in Australia, and holdings in Taiwan and South Korea. Given the Fund's mandate, the return of the narrow index is a more meaningful comparison.

Relative to the narrow index, stock selection and an overweight position in the United Kingdom also detracted from performance, as did stock selection in Spain.

Conversely, stock selection and an overweight position in the information technology sector contributed to performance relative to the narrow index, as did stock selection and an underweight position in communication services. On a country basis, stock selection in Switzerland contributed.

Over the period, the Fund's cash position decreased as the portfolio management team initiated positions in companies it believed to have strong growth prospects and the capacity to pay dividends.

Net Assets

The Fund's NAV increased by 102.7% to \$320.9 million at March 31, 2021, from \$158.3 million at March 31, 2020. This change was composed primarily of \$55.1 million in net income (including dividend and interest income) from investment performance, after deducting fees and expenses, \$111.3 million in net sales (which includes an inflow of \$164.2 million relating to fund merger activity), and \$3.8 million in cash distributions.

As a result of these investments, the Fund is subject to large transaction risk as discussed in the Prospectus. CLIML manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors.

Fees and Expenses

The management expense ratio (“MER”) for Q Series of 2.54% during the year ended March 31, 2021, was unchanged from the MER for the year ended March 31, 2020. The MERs (before and after waivers or absorptions, if any) for all series are presented in the *Financial Highlights* section of this report. The MERs for D5 Series, D8 Series, HW Series, HW5 Series, L5 Series and L8 Series increased due to an increase in fund costs. The MER for QF5 Series decreased due to a decrease in fund costs.

Recent Developments

Governments worldwide have enacted various measures in seeking to combat the spread of the COVID-19 virus. These measures have led to significant volatility in equity markets and material disruption to businesses globally, resulting in an economic slowdown.

Ongoing uncertainty regarding the duration and long-term impact of the pandemic and the implementation of vaccination programs, as well as the efficacy of government and central bank monetary and fiscal interventions, may continue to affect the Fund’s performance in future periods.

The portfolio management team searches global equity markets for attractively valued companies, and the Fund’s security selection is not driven by macroeconomic events. The team looks for companies with both the capacity and the commitment to pay dividends, paying attention to factors such as strong balance sheets and robust cash flow. The team also expects stocks to have growing dividends and sustainable dividend payout ratios. At period-end, the Fund was concentrated in high-yield securities but was well diversified across sectors and regions.

Following the approval of the Mackenzie Funds’ Independent Review Committee (“IRC”), Global Dividend Equity Class (Setanta) merged into the Fund on June 26, 2020. Mackenzie did not consider this merger to be a material change from the Fund’s perspective.

On August 14, 2020, the Fund was renamed Canada Life Global Dividend Equity Fund (Setanta).

Effective January 1, 2021, the Fund’s manager and trustee changed from Mackenzie to CLIML following CLIML’s receipt of regulatory approval to be registered as an investment fund manager. This change received a positive recommendation from the Mackenzie Funds’ IRC. Mackenzie continues to provide certain administrative and transfer agency services to the Fund.

Also effective January 1, 2021, the Mackenzie Funds’ IRC was replaced by the Canada Life Funds’ IRC, which consists of the following three members: Steve Geist (Chair), Joanne De Laurentiis and Linda Currie.

Related Party Transactions

The following arrangements result in fees paid by the Fund to CLIML or to companies affiliated with the Fund.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Mackenzie for the period from April 1 to December 31, 2020 (“the pre-manager change period”), and to CLIML thereafter at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. After the pre-manager change period, CLIML paid the administration fee to Mackenzie for providing day-to-day administration services, including financial reporting, communications to investors and securityholder reporting, maintaining the books and records of the Fund, NAV calculations, and processing orders for securities of the Fund. In return for the administration fees, Mackenzie pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also *Management Fees*.

Other Related Party Transactions

Canada Life is a subsidiary of Power Corp. of Canada. Mackenzie is wholly owned by IGM Financial Inc., which in turn is also a subsidiary of Power Corp. of Canada. Companies related to Power Corp. of Canada are therefore considered affiliates of CLIML and Mackenzie. At March 31, 2021, the Fund held the following investment(s) in companies affiliated with CLIML: \$9.3 million invested in securities issued by Groupe Bruxelles Lambert SA. The investment(s) represented 2.9% of the Fund’s NAV. In making the investment(s), Mackenzie relied on the approval of the Mackenzie Funds’ IRC in the pre-manager change period and CLIML relied on the approval of the Canada Life Funds’ IRC thereafter. Both IRCs issued the approval on the basis that the investment(s) would be made in compliance with Mackenzie’s and CLIML’s policies. Mackenzie’s and CLIML’s policies are designed to ensure that any related party transaction (i) is made free from any influence by an entity related to Mackenzie and CLIML and without taking into account any considerations relevant to an entity related to Mackenzie and CLIML; (ii) represents the business judgment of Mackenzie and CLIML, uninfluenced by considerations other than the best interests of the Fund; and (iii) achieves a fair and reasonable result for the Fund.

Investment funds managed by CLIML and segregated funds managed by Canada Life and its subsidiaries may invest in the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. At March 31, 2021, funds managed by CLIML and segregated funds managed by Canada Life owned 38.2% of the Fund’s NAV. All related party transactions are based on the NAV per security on each transaction day.

At March 31, 2021, Canada Life had an investment of \$36,121 in the Fund (less than 0.1% of the Fund’s NAV).

Mackenzie relied on an approval issued by the Mackenzie Funds’ Independent Review Committee to proceed with the merger of Global Dividend Equity Class (Setanta) into the Fund in June 2020.

Mackenzie relied on a recommendation issued by the Mackenzie Funds’ Independent Review Committee to replace Mackenzie with CLIML as the Fund’s manager and trustee in January 2021.

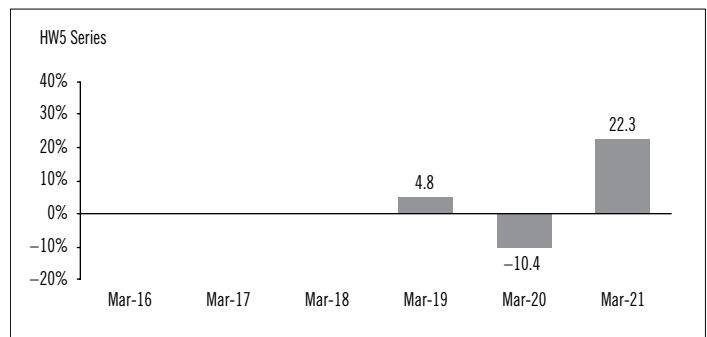
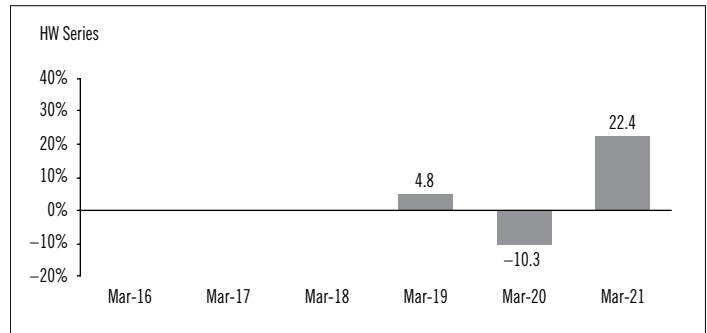
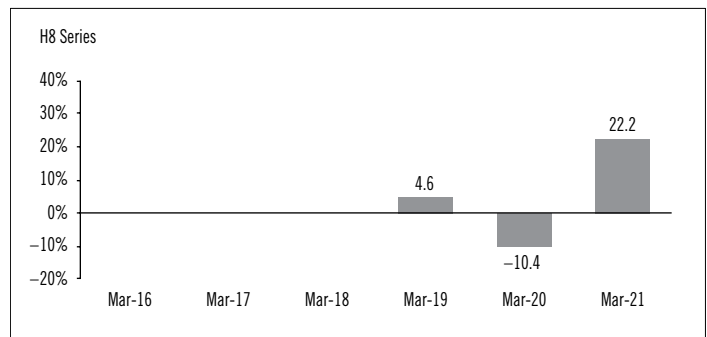
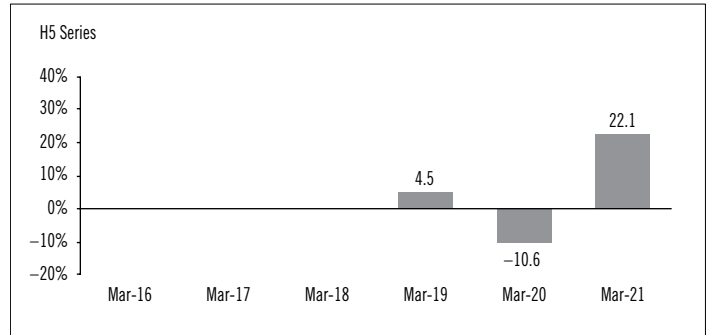
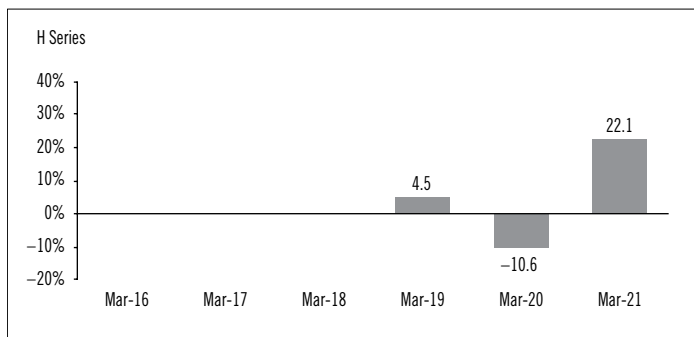
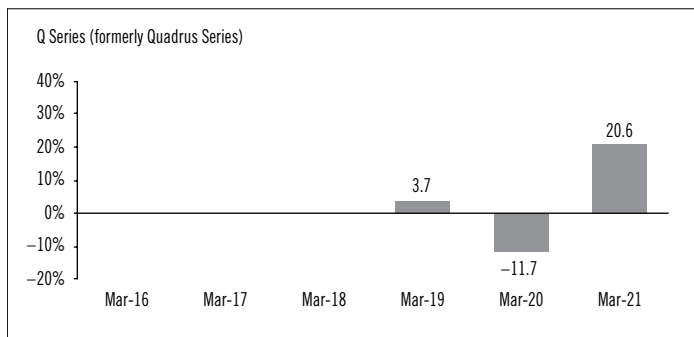
Past Performance

The MSCI World High Dividend Yield (Net) Index includes large- and mid-cap stocks across 23 developed market country indices. The index selects equities from the MSCI World Index (excluding real estate investment trusts) with higher-than-average dividend yields that are both sustainable and persistent. The index also applies quality screens and reviews 12-month past performance to omit stocks with potentially deteriorating fundamentals that could force them to eliminate or reduce dividends. Net total returns are calculated after the deduction of withholding tax from the foreign income and dividends of its constituents.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by Mackenzie, in the pre-manager change period, and by CLIML thereafter, in part to pay Setanta Asset Management Ltd, an affiliate of both Mackenzie and CLIML, for investment advisory services, including managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions and making brokerage arrangements for the purchase and sale of the investment portfolio.

Quadrus Investment Services Ltd. ("Quadrus"), an affiliate of CLIML and Mackenzie, is the principal distributor for the Fund and is paid trailing commissions out of the management fees. In the pre-manager change period, Canada Life provided certain services to Mackenzie in connection with Mackenzie's portfolio management activities. Canada Life was responsible for paying certain administrative costs and all sales commissions, trailing commissions and any other compensation (collectively, "distribution-related payments") to registered dealers whose clients invest in the Fund. As such, Quadrus and Canada Life received a portion of the management fees that the Fund paid to Mackenzie. Approximately 77% of the total management fees that Mackenzie received from the Canada Life Mutual Funds during the pre-manager change period was paid under these arrangements.

Subsequent to the change in manager, CLIML used the management fees to fund distribution-related payments to Quadrus and to registered dealers and brokers whose clients invest in the Fund.

Mackenzie and CLIML used approximately 38% of the total management fee revenues received from all Canada Life Mutual Funds during the year to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 42% of the management fees paid by all applicable series of the Fund during the year. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series. The higher proportion of distribution-related payments is primarily attributable to sales commissions related to gross sales of redemption charge securities of the Fund.

H Series, H5 Series and H8 Series securities are offered to investors investing a minimum of \$500, who are enrolled in a Quadrus-sponsored fee-for-service or wrap program and who are subject to an asset-based fee. Investors in H5 Series and H8 Series securities also want to receive a monthly cash flow of 5% or 8% per year, respectively.

HW Series, HW5 Series and HW8 Series securities are offered to high net worth investors investing a minimum of \$100,000 and who have eligible minimum total holdings of \$500,000, who are enrolled in a Quadrus-sponsored fee-for-service or wrap program and who are subject to an asset-based fee. Investors in HW5 Series and HW8 Series securities also want to receive a monthly cash flow of 5% or 8% per year, respectively.

L Series, L5 Series and L8 Series securities are offered to investors investing a minimum of \$100,000 and who have eligible minimum total holdings of \$500,000. Investors in L5 Series and L8 Series securities also want to receive a monthly cash flow of 5% or 8% per year, respectively.

N Series, N5 Series and N8 Series securities are offered to investors investing a minimum of \$100,000, who have eligible minimum total holdings of \$500,000, and who have entered into an N type series account agreement with CLIML and Quadrus. Investors in N5 Series and N8 Series securities also want to receive a monthly cash flow of 5% or 8% per year, respectively.

QF Series and QF5 Series securities are offered to retail investors investing a minimum of \$500. Investors are required to negotiate their advisor service fee, which cannot exceed 1.25%, with their financial advisor. Investors in QF5 Series securities also want to receive a monthly cash flow of 5% per year.

QFW Series and QFW5 Series securities are offered to high net worth investors investing a minimum of \$100,000 and who have eligible minimum total holdings of \$500,000. Investors are required to negotiate their advisor service fee, which cannot exceed 1.25%, with their financial advisor. Investors in QFW5 Series securities also want to receive a monthly cash flow of 5% per year.

Series R securities are offered only to other funds managed by CLIML on a non-prospectus basis in connection with fund-of-fund arrangements.

An investor in the Fund may choose among different purchase options that are available under each series. These purchase options are a sales charge purchase option, a redemption charge purchase option, a low-load purchase option and a no-load purchase option. The charges under the sales charge purchase option are negotiated by investors with their dealers. The charges under the redemption charge and low-load purchase options are paid to CLIML if an investor redeems securities of the Fund during specific periods. Not all purchase options are available under each series of the Fund, and the charges for each purchase option may vary among the different series.
