Management Discussion of Fund Performance

November 10, 2020

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the period ended September 30, 2020 (the "period"), that have affected the Fund's performance and outlook. If the Fund was established during the period, "period" represents the period from inception to the end of the fiscal period. For information on the Fund's longer-term performance, as applicable, please refer to the *Past Performance* section of the report. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund's Q Series (formerly Quadrus Series) securities is discussed below. The performance of all series is shown in the *Past Performance* section of the report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series.

During the period, the Fund's Q Series securities returned 4.6% (after deducting fees and expenses paid by the series). This compares with a return of 21.7% for the Fund's broad-based index, the MSCI World (Net) Index, and a return of 9.2% for the Fund's narrow index, the S&P Global Infrastructure Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Global equity markets advanced over the period as improved economic activity and slowing COVID-19 infection rates in some regions globally prompted expectations of a recovery. Equity valuations were supported by low bond yields as most central banks kept interest rates low or reduced rates. U.S. equities recovered to an all-time high. Asian markets generally underperformed. Although many European countries outperformed, U.K. equities underperformed as the United Kingdom and the European Union continued trade negotiations. Currency movements reduced returns in Canadian dollar terms.

Within the S&P Global Infrastructure Index, New Zealand, Mexico and Australia were the strongest performers in Canadian dollar terms, while Singapore, China and Canada were the weakest. From a sector perspective, industrials was the strongest performer, while energy was the weakest.

The Fund underperformed the broad-based index, with the Fund's cash position detracting from performance as equity markets rose. Given the Fund's mandate, the return of the narrow index is a more meaningful comparison.

The Fund underperformed the narrow index, with stock selection in the energy and industrials sectors detracting from performance. On a country basis, overweight exposure to China and Hong Kong, underweight exposure to New Zealand and stock selection in Mexico detracted from performance.

Conversely, an underweight position in the energy sector contributed to performance relative to the narrow index, partially offsetting the negative impact of stock selection. Stock selection in the utilities sector also contributed. On a country basis, stock selection in the United Kingdom, Singapore and Brazil contributed to performance, as did overweight exposure to Italy and Japan.

Over the period, the Fund's exposure to China and the United States decreased as a result of the quantitative processes employed by the portfolio management team. At the sector level, exposure to industrials increased, while exposure to utilities decreased.

Net Assets

The Fund's NAV increased by 3.5% to \$46.5 million at September 30, 2020, from \$45.0 million at March 31, 2020. This change was composed primarily of \$2.6 million in net income (including dividend and interest income) from investment performance, after deducting fees and expenses, \$0.4 million in net redemptions, and \$0.7 million in cash distributions.

As a result of these investments, the Fund is subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors.

Fees and Expenses

The annualized management expense ratio ("MER") for Q Series of 2.55% during the period ended September 30, 2020, was unchanged from the MER for the year ended March 31, 2020. The MERs (before and after waivers or absorptions, if any) for all series are presented in the *Financial Highlights* section of this report. The MER for D5 Series decreased due to a decrease in fund costs.

Recent Developments

The duration and long-term impact of the novel coronavirus (COVID-19) pandemic on businesses and markets, and the extent of additional economic relief measures which may be offered by some governments and central banks, are unknown at the reporting date. This uncertainty means it is impossible to reliably estimate the impact on the financial results and position of the Fund in future periods.

The portfolio management team believes the COVID-19 pandemic has introduced challenges that will test the resilience of the infrastructure sector, as previously stable demand and revenues diminish in response to supply chain disruptions and changes in consumer behaviour. For example, demand for electricity has declined in some countries, and the shift to remote working has impacts on other industries, such as real estate. Despite continued underinvestment, in the team's opinion, governments and businesses agree that improving the quality of infrastructure is imperative for economic growth. The team believes that threats such as climate change, pandemics and overpopulation will prompt infrastructure companies to embrace resilient digital technologies in order to ensure the continued provision of services.

The Fund ended the period with an overweight position in the utilities sector and underweight positions in the energy and industrials sectors, relative to the narrow index.

On August 14, 2020, the Fund was renamed Canada Life Global Infrastructure Equity Fund (London Capital).

Effective on or about January 1, 2021, the Fund's manager and trustee will change to Canada Life Investment Management Ltd. ("CLIML"), an affiliate of Mackenzie. This change received a positive recommendation from the Mackenzie Funds' Independent Review Committee and is subject to regulatory approval for CLIML to be registered as an investment fund manager.

Concurrent with this change, Mackenzie will replace GLC Asset Management Group Ltd. as sub-advisor to the Fund.

Related Party Transactions

The following arrangements result in fees paid by the Fund to Mackenzie or to companies affiliated with the Fund.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Mackenzie at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, Mackenzie pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also *Management Fees*.

Other Related Party Transactions

Investment funds managed by Mackenzie invest in the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. At September 30, 2020, funds managed by Mackenzie owned 73.0% of the Fund's NAV. All related party transactions are based on the NAV per security on each transaction day.

At September 30, 2020, The Canada Life Assurance Company, an affiliate of Mackenzie, had an investment of \$11,527 in the Fund (less than 0.1% of the Fund's NAV).

The Fund did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by Mackenzie in part to pay GLC Asset Management Group Ltd., an affiliate of Mackenzie, for investment advisory services, including managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions and making brokerage arrangements for the purchase and sale of the investment portfolio.

Quadrus Investment Services Ltd. ("Quadrus"), an affiliate of Mackenzie, is the principal distributor for the Fund and is paid trailing commissions out of the management fees. The Canada Life Assurance Company, which is also an affiliate of Mackenzie, provides certain services to Mackenzie in connection with Mackenzie's portfolio management activities. The Canada Life Assurance Company is responsible for paying certain administrative costs and all sales commissions, trailing commissions and any other compensation (collectively, "distribution-related payments") to registered dealers whose clients invest in the Fund. As such, Quadrus and The Canada Life Assurance Company receive a portion of the management fees that the Fund pays to Mackenzie. Approximately 78% of the total management fees that Mackenzie received from the Canada Life Mutual Funds during the period was paid under these arrangements.

Mackenzie used approximately 43% of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 40% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.
