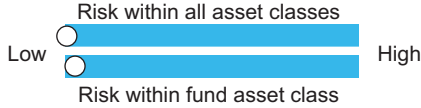

Investment management style

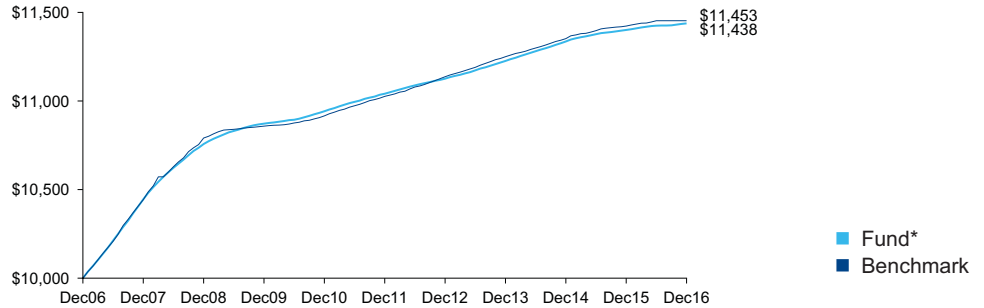
The Fund invests in short term instruments with low risk and low volatility.

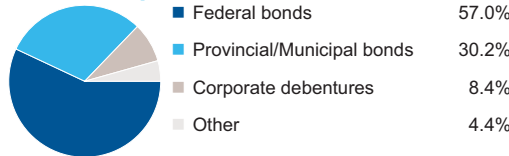
